6. Financial report 2009

a) Amendments to the constitution as discussed and approved by BPSU Exco on 23/01/2010. New Qualifying Scores for shotgun events

i) Manton (Shotgun Flintlock) - New Qualifying score = 36/50

ii) Lorenzoni (Shotgun) - New Qualifying score = 42/50

b) Amendment relevant to shooting belt width and attachment points apart (15 cm / 6 inches)

The shooting belt on rifles must have 2 attachment points to the rifles, but they may not be closer together than 15 cm / 6 inches
Proposed by Japie Maritz and seconded by Johan de Beer

c) 2010 World Championship, Short Range, Portugal

Application for Protea Colours for the team that was announced prior to the meeting must be done as soon as possible. All members must forward copies of their ID documents and passports to Corena not later than Tuesday, 1st June 2010.

d) Qualification for Bisley 2011

anyone that is interested to qualify for the Protea team for the MLAIC Long Range World Championship in Bisley, England in 2011 must contact Japie immediately. He will coordinate the group and monitor the qualifying shoots.

e) World Records set at Camp Butner, USA

World records were broken by Merwe van Rensburg, Eugene Kuisis and Tertius Smit at the 900 yards in Camp Butner in 2007. They received BPSU record certificates.
